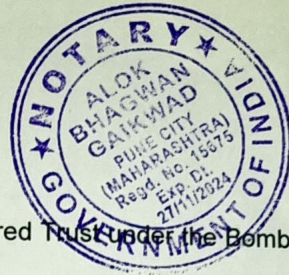

6. That the school will not open classes under CBSE pattern, particularly classes IX/X/ XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and correspondent/manager for the school have individually gone through the provision contained in the affiliation and examination byelaws and the circular issued by the board from time to time. The School undertakes to abide by the provision contain in the affiliation and examination byelaws directions issues from time to time and the law of the land.

14. That the school shall strive to make efforts for conservation of environment.

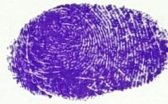
